FINAL REMINDER TO STUDENTS WHO HAVE NOT DEPOSITED

Mode of Payment: Fee will be accepted through Demand Drafts favoring **Registrar, DTU A/C No-34918913564** payable at State Bank of India, DCE Branch, Bawana Road, Delhi-110042. **NRI** students shall be required to deposit the fee through Demand Drafts favoring **Registrar, DTU A/C No-34918913564** and payable at New York in US Dollar (US\$) only payable at State Bank of India, DCE Branch, Bawana Road, Delhi-110042.

All concerned HoDs are requested to direct the defaulters of their departments to deposit the fee online immediately and not allow them to attend the classes.


