Instructions to Candidates Invited for Second Round of Counseling of MBA (Executive) 2020-2022 Batch

In view of the ongoing Corona pandemic, DSM, Delhi Technological University (DTU) is conducting MBA (E) Admission counselling process online so as to avoid inconvenience to the candidates. The selected candidates are required to follow these instructions:

1. Please find below the tentative list of selected candidates for Second round of counselling.
2. Please note that the document verification process is underway. If no discrepancy is found in the documents, the selected candidates will be able to pay the Admission Fees online via their admission portal.
3. The payment of Admission Fees will be through online mode only. Selected candidates are required to login in their respective portals on September 4, 2020. The link for payment of Admission Fees will be active. Upon payment of Admission Fees, the candidate will be granted provisional admission*. (provisional letter of admission can be collected from DSM office on September 10, 2020)
4. The candidate is required to pay the Admission fees latest by September 7, 2020, 7:00 P.M.
5. The Candidates are required to email the proof of fee payment and No Objection Certificate from the employer with current designation of the candidate and permission to attend the classes for the whole day on Saturday and Sunday during all the four semesters in the period 2020-22 on emba.admission@dtu.ac.in

*Admission is subject to the verification of the original documents. Candidates are required to submit all original documents along with ONE set of self-attested photo- copies of the original documents for the purpose of verification, as and when the restrictions for COVID-19 are lifted and students start reporting physically in University. The original documents will be returned to the students after verification.

Note: If at any stage of the program, it is found that the candidate does not fulfill the eligibility criteria, his/her admission shall be cancelled.

Fee: The fees for the session 2020-2022 is Rs. 2, 31,500/- (Two Lakh Thirty One Thousand Five Hundred only) for First year. The selected candidates are required to pay the full fees of first year.
