

## **M.Tech Admission (Full-Time/Part-Time/Sponsored Full-Time) 2020-21** **Instructions to Candidates for Spot Round of Counselling for IBT**

20<sup>th</sup> August 2020

In view of the ongoing Corona pandemic, Delhi Technological University (DTU) is conducting M.Tech Admission counselling process online so as to avoid inconvenience to the candidates. The selected candidates are required to follow these instructions:

1. Please find below the tentative list of selected candidates for spot round of counselling.
2. The payment of Admission Fees will be through online mode only.
3. Selected candidates are required to login in their respective portals on 24<sup>th</sup> August, 2020. The link for payment of Admission Fees will be active. Upon payment of Admission Fees, the candidate will be granted provisional admission\*.
4. The candidate is required to pay the Admission fees latest by 25<sup>th</sup> August 2020, by 5:00 P.M. Please note that any requests for extension of dates/ time will NOT be entertained.
5. In case the selected candidate has not paid the Admission Fees by the required date, they will forfeit their seats and will not be considered for further rounds of admission except for spot round(s).
6. In case a sponsored full time or part time candidate who has not submitted sponsored certificate or NOC, they will be considered for provisional admission subject to submission of an undertaking on admission support email ([mtechcoordinator@dtu.ac.in](mailto:mtechcoordinator@dtu.ac.in)) stating that they will submit the sponsored and NOC certificates by 30<sup>th</sup> August 2020, 5 pm on admission support email ([mtechcoordinator@dtu.ac.in](mailto:mtechcoordinator@dtu.ac.in)), failing to which, they will forfeit their seats and their admission will be cancelled.

\*Admission is subject to the verification of the original documents. Candidates are required to submit all original documents along with ONE set of self-attested photo-copies of the original documents for the purpose of verification, as and when the restrictions for COVID-19 are lifted and students start reporting physically in University. The original documents will be returned to the students after verification.

### **NOTES:**

- The candidates are advised NOT to wait till the last moment and pay the Admission fees in time. Any requests for extension of time due to any reason will not be entertained.
- The allotment of seats is done strictly on the basis of merit list based on valid GATE score for M.Tech Full time program as per the criterion mentioned in the brochure.
- The candidates must ensure that they fulfil the eligibility criteria of admission as per M.Tech admission brochure. At any stage of Admission process or later, if it is found that candidate has suppressed any material information or wilfully submitted false information/documents, his / her candidature will be cancelled with immediate effect and admission fee will not be refunded. Legal proceedings may be initiated against such candidates.
