MBA (Family Business and Entrepreneurship) Admission (2020-22 Batch)

Instructions to Candidates for first Round of Counselling

In view of the ongoing Corona pandemic, Delhi Technological University (DTU) is conducting MBA (Family Business and Entrepreneurship) Admission counselling process online to avoid inconvenience to the candidates. The selected candidates are required to follow these instructions:

1. Selected candidates are required to login in their respective portals on 21th September, 2020. The link for payment of Admission Fees will be active. Upon payment of Admission Fees, the candidate will be granted provisional admission.
2. The candidate is required to pay the Admission fees latest by 23th September, 2020, by 5:00 P.M. Please
3. Note that any requests for extension of dates/ time will NOT be entertained. At any stage of Admission process or later, if it is found that candidate has suppressed any material information or wilfully submitted false information/documents, his / her candidature will be cancelled with immediate effect.
4. Forged Documents: If the documents you submit are found to be forged / fake, then the seat allotted will be withdrawn and you will be debarred from any seat. MBA(FBE) admission committee may also initiate legal action in such a case.
5. The provisional admission is subject to fulfilment of following conditions:
 - a) Mandatory percentage of marks in graduation (as specified in admission brochure)
 - b) Valid GST number
 - c) 10th Class passing Certificate for DoB proof
 - d) OBC-NCL certificate for the year 2020-2021, if applicable
 - e) EWS certificate for the year 2020-2021, if applicable
 - f) SC/ST certificate issued by competent authority (as specified in admission brochure), if applicable
 - g) Defence certificate issued by competent authority (as specified in admission brochure), if applicable
 - h) Kashmiri migrant certificate issued by competent authority (as specified in admission brochure), if applicable

Note- The candidates must ensure that they fulfil the eligibility criteria of admission as per admission brochure. At any stage of Admission process or later, if it is found that candidate has suppressed any material information or wilfully submitted false information/documents, his / her candidature will be cancelled with immediate effect and admission fee will not be refunded. Legal proceedings may be initiated against such candidates. Admission is subject to the verification of the original documents. Candidates are required to submit all original documents along with ONE set of self-attested photocopies of the original documents for the purpose of verification, as and when the restrictions for COVID-19 are lifted and students start reporting physically in University. The original documents will be returned to the students after verification.

Payment of Fee:

- All the candidates who get an allotment in this round will have to pay part admission fee (Rs.1,90,000 – Rupees One Lakh Ninety Thousand only) online as per the admission schedule, failing which his/her allotted seat will stand automatically cancelled. However, such candidates are eligible for spot round of counseling.
- No part payment will be accepted.
- The candidates are advised NOT to wait till the last moment and pay the Admission fees in time. Any requests for extension of time due to any reason will not be entertained.
