**Instructions to Candidates Provisionally Selected in MBA (Executive) 2017-19 Batch**

The following students are required to report for counseling cum admission process on 19.07.2017 (Wednesday) at 10:30 A.M. at Delhi School of Management, Delhi Technological University, Bawana Road, Delhi-110042.

**Note: There are 7 seats available in the General Category for which next 20 candidates (from the waiting list) are called. The offer of the admission shall be strictly on the basis of merit list. Therefore, calling of candidate for the counseling shall not be considered as entitlement for admission. The seats will be offered first to the candidates having the higher rank in the merit list. In case, a candidate is absent, the seat will be offered to the next candidate in the merit list. The students are provisionally selected and are subject to verification of documents. The candidates are required to bring the following documents in original as well as a set of photocopy duly attested:**

1. Class X Certificate as a proof of Date of Birth.
2. Degree and all Mark Sheets of qualifying examinations.
3. Original documents in respect of experience mentioned in application form.
4. No Objection Certificate from the employer with current designation of the candidate and permission to attend the classes for the whole day on Saturday and Sunday during all the four semesters in the period 2017-19.
5. Demand Draft.

**Note:** Admission of the candidate shall be confirmed only after providing all documentary proof of educational qualification, experience and subsequent verification of both.

**Fee:** The fee for 2017-19 batch is Rs. 1, 94,000/= (One Lakh Ninety Four Thousand only) for First year and Rs. 2, 21,000/= (Two Lakh Twenty One Thousand only) for Second year. The fee is to be paid by Demand Draft /Pay Order drawn in favour of the “**Registrar, Delhi Technological University**” payable at Delhi. The candidates are required to deposit the fee on the day of admission only. No part payment will be accepted. No other mode of payment is acceptable. If a candidate fails to deposit the fee on the same day, his admission will stand cancelled and seat shall be offered to the next candidate in the wait list.

**Note:** The candidates who take admission next 19.07.2017, shall not be eligible for refund of fee.
