Administration /Universities /Public Sector Undertakings/Statutory or Autonomous Organizations/Recognized Research institute etc should send their applications "Through proper channel" alongwith attested copies of ACRs for the last 5 years, Vigilance Clearance Certificate and Work & Conduct report from the present employer. (For transfer on deputation basis only)
- c. Period of deputation will be initially for one year which will be extendable based on satisfactory performance. The persons appointed on deputation basis will draw the Pay & Allowances as Government of India instructions.
- d. Incomplete applications and those received after the due date shall be rejected and shall not be considered in any case. The selection will be based upon the performance at the interview, service record, ACRs (for posts of transfer on deputation basis) and written test, if required etc.
