NOTICE FOR EMPANELMENT

Sub: Appointment as Panel Counsel (Civil) in Delhi Technological University for conducting civil cases in Hon'ble High Court and Central Administrative Tribunal and District and Subordinate Courts of Delhi.

The Delhi Technological University proposes to empanel advocates as Panel Counsel (Civil). Eligible and desirous advocates having required qualification and experience may apply in the prescribed Proforma.

Qualification

Bachelor degree in Law from a recognised university and registration with Bar Council Delhi.

Experience required for High Court & Central Administrative Tribunal

- i) Professional experience of atleast 5 years in handling Govt. Department cases (Writ petitions/appeals) in High Courts and Central Administrative Tribunal (CAT).
- ii) Applicant must possess sound working knowledge on procedures of High Courts, Central Administrative Tribunal and Services Matters and must have good communication skills and good knowledge of law.

Experience required for District and Subordinate Courts

- i) Professional experience of atleast 4 years in the High Courts or District Courts.
- ii) Applicant must possess sound working knowledge on procedures of District Courts, Consumer Forums, Labour Courts and Services Matters and must have good communication skills and good knowledge of law.

Mode of Selection-

1. The mode of selection will be interaction by selection committee.
2. In case a large number of applications are received, short-listing of applications may be done. The University reserves the right to decide the criteria of short-listing.

3. Short-listed candidates will then be called for interaction. Intimation will be sent at the correspondence address or email address, as given in the application form or over the telephone number given by the applicant.

4. Candidates will have to produce all original documents at the time of the interview/interaction.

5. Candidates may see the terms and conditions of the fee/remuneration payable to Panel advocates on the website of the Department of Law, Justice & Legislative Affairs.

The University reserves the right to accept or reject any application without assigning any reason. The application submitted will not bind this University to consider him/her for selection.
