I am directed to refer to U.O No.25(10)/RN-2018/113/A-1515 Dated 19/03/2018 of Jt. Secretary to Lt. Governor, Raj Niwas, Delhi addressed to SO to Chief Secretary, Delhi, inviting the attention of all concerned Public Authorities regarding the decision of Hon'ble High Court of Madhya Pradesh, Gwalior Bench (M.P) in Writ Petition No.20420/2017(PIL) wherein Hon'ble Court cited the official communication of Chief Secretary Govt. of Haryana Dated 29/01/2008 addressed to HODs in Haryana about ban on the "Dalit" word as interchangeable with the word "Scheduled Castes".

In this regard all departments and its functionaries are requested to refrain use from the nomenclature "Dalit" for the members belonging to Scheduled Castes and Scheduled Tribes as the same does not find mentioned in the Constitution of India or any statute.
