This is in continuation of Circular dated 18.05.2021 towards submission of fellowship continuation forms in respect of Ph.D. Research Scholars who are getting fellowship from DTU.


It has been observed that the continuation fellowship forms are not being received from most of the Departments by 2nd of every month which causes delay in the processing/release of the fellowship of Research Scholars.

Therefore, it is hereby informed that after 2nd of every month, if continuation forms are not received from the HOD(s) of the respective Department(s), by default, it will be presumed that the Research Scholar(s) are continuing in the Department and the fellowship will be processed as per earlier continuation fellowship form submitted by the R/Scholar(s).

If any discrepancy/deficiency would occur in case of continuous absence of research scholar and non-receipt of the timely continuation form, at any point w.r.t. undue release of fellowship to the Research Scholar(s), the accountability shall be of Supervisor & the HOD of the concerned Department and the Academic-PG Branch will not be liable for any discrepancy.


