2. Minimum eligibility for each position is governed by the Regulations issued by the UGC/ AICTE/ NCTE/PCI/COA from time to time in this regard. Notification and qualifications specific to individual positions are given at www.curaj.ac.in
3. The date for determining the eligibility of all candidates in every respect will be the last date of submission of applications.
4. The medium of instruction at CURAJ is English and teachers are required to teach in English.
5. Candidates are advised to ensure/satisfy themselves that they fulfil all the eligibility criteria. It is the responsibility of the candidate to assess his/her eligibility for the post for which he/she is applying.
