(MBA) Programme

The Master of Business Administration (MBA) programme focuses on enhancing the capabilities of the students to lead and manage 21st century businesses. The key focus of the programme is to deliver broad business understanding, effective communication skills, strategic problem-solving skills, networking skills, resource and time management skills, analytical skills, and leadership capabilities. This course is designed to be highly industry-centric which will enable students to learn all the necessary management knowledge and enhance the design thinking capability for solving problems creatively. The curriculum helps students in inculcating cross-functional and innovative decision-making skills. This programme bestows knowledge and training in such a way that the students strive to make a positive mark in the world.

The MBA programme covers diverse business areas such as accounting, finance, marketing, human resources, operations, and decision science. The specializations offered in this programme are Marketing Management, Financial Management, Human Resource Management, Supply Chain Management, and Information Technology Management.

The MBA programme is offered at Delhi School of Management (DSM) and University School of Management and Entrepreneurship (USME). The USME was established in East Delhi campus (EDC) of DTU in the year 2017, to fulfill its mission of offering a portfolio of the highest quality of programs aimed at emerging areas such as analytics and venture development, and the creation of an ecosystem for learning, research, and practice in management and entrepreneurship. It aims to grow into a nodal center for entrepreneurship and to become a multi disciplinary practise-oriented business school.

Situated in the East of Delhi, the Campus comprises three disciplines of Management, Economics and Innovation, Entrepreneurship, and Venture Development, with faculty having a background of leading premier institutions such as the IIM (Calcutta, Lucknow), the IIT (Delhi, Madras, Kharagpur, Ropar), the FMS, Delhi University, JNU, New Delhi; Delhi School of Economics (DSE) etc.

It houses an ecosystem that is not only multidisciplinary, but multidimensional in its range of activities. There is a network of student entrepreneurs from the MBA Entrepreneurship streams, and ventures (including the DTU-IIF incubates), mentors and professionals, in-house and visiting faculty from premier institutions and industry, and a vibrant student community.

USME not only offers degree Programmes at the UG, PG, and doctoral levels, but it has also conducted intense workshops on Entrepreneurship, Business Strategy, R for Machine Learning, the Start-up Conclave, series of workshops under the University Innovation Council Programme, career development in various fields like analytics, amongst many such industry driven interactions, to provide a lot of co-curricular learning. The cultural fest "Traction", including business contests and many other celebrations of youthful artistic expression, including twenty three clubs in different professional, arts and other interest areas, all contribute to a rich extra-curricular life on Campus. These activities have drawn students from across India, including from the IIMs and other premier colleges, and students also participate in many national level festivals and competitions.

Last year, the second USME Corporate Engagement Week, fair resulted in over three hundred fifty internship offers to undergraduate and graduate students of USME, with over seventy companies participating in the multi-University event collaborating with NSUT, IGDTUW and Ambedkar University. This will be extended fully to the PG level internships in this coming session. The placement of MBA candidates is also carried out through the Central DTU Training and Placement Cell, where last year, over fifty companies presented final placement opportunities for MBA, jointly with DSM.

Course Curriculum of MBA

MBA Programme is a two-year full time professional programme spread over four semesters, which combines rigorous academic schedules with proactive efforts to develop new perspectives and a higher level of knowledge and understanding.

The Programme focuses on inculcating effective managerial and leadership skills. The first year of the programme offers core courses to develop the right attitude, knowledge and skills which are essential for a leader in the long term. *The elective courses offered in the second year give students an opportunity to delve deeper in their respective areas of specialization and thus cater to the role and sector specific career objectives.*

Admission Process, CMAC-2022

Delhi School of Management (DSM) and University School of Management and Entrepreneurship (USME), DTU follows an online process of application for the MBA programme. Centralized Counselling for admission to MBA programme for pioneering universities of Govt. of NCT of Delhi, namely Delhi Technological University (DTU), Netaji Subhas University of Technology (NSUT) and Indira Gandhi Delhi Technical University for Women (IGDTUW) will be conducted through Common Management Admission Committee CMAC, 2022.

Prospective candidates are required to fill a single online application form on the website http://www.dtu.ac.in to participate in the centralized admission under CMAC-2022.

ELIGIBILITY AND ADMISSION PROCEDURE

- a) A candidate who has passed any bachelor degree examination with minimum 60% marks in aggregate or equivalent CGPA from a recognised university/institution and valid CAT-2021 /MAT-2021 /MAT-2022 percentile or Graduation degree with one year experience is eligible to apply. However, a relaxation of 10% in marks shall be given in eligibility criteria to SC/ST/PwD candidates.
- b) The student should hold a degree from any of the universities incorporated by an act of the central or state legislature in India, or other educational institutions established by an Act of Parliament or declared to be deemed as a university under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of Education, Government of India.
- c) Those who are appearing in final semester examination may also apply, provided that they submit

- i. The proof of eligibility by a specific date declared by the University, and
- ii. valid CAT/MAT percentile at the time of application.

otherwise the admission of the candidate to the university will be cancelled. Candidates appearing in final semester/year should have at least 60% aggregate marks at the time of submission of application.

In case the conversion formula for CGPA is not provided by the concerned Institute/ University, equivalent percentage shall be computed as per following formula:

$CGPA \times 10 = Percentage of Marks$

Note: At any stage of the Programme, if it is found that the candidate does not fulfil the eligibility criteria, his/ her admission shall be cancelled and fee shall not be refunded.

INTAKE

The annual intake of this programme is 150 at DSM and 120 at USME.

The reservations of the seats for SC/ST/OBC/EWS and sub categories Defence/ PWD are as per the norms. One seat over and above the total intake in each campus is reserved for Kashmiri Migrants. However, there will be no relaxation in the minimum eligibility criteria for Kashmiri Migrants.

Reservation Policy

- **a) Scheduled Caste (SC):** 15 % of the total seats are reserved for Scheduled Caste candidates.
- **b) Scheduled Tribe (ST):** 7.5 % of the total seats are reserved for Scheduled Tribe candidates.
- c) Other Backward Class (OBC- NCL): 27% of the total seats are reserved for Other Backward Class (Non-Creamy Layer) candidates.
- **d) Economically Weaker Section (EWS):** 10% of the total seats are reserved for EWS category as per the office order DHE.1 (119)/Estt./2018-19/2549-76 dated 17/06/2019

Sub-categories namely 'Defence' and 'Person with Disability' are available under each category (General, SC, ST, OBC-NCL).

e) Defence (CW): 5% of the total seats (Horizontal) in each main category are reserved for candidates belonging to Defence sub-category in the following order of priority:

Priority I - Widows/wards of Defence Personnel killed in action.

Priority II - Wards of disabled in action and boarded out from service.

Priority III - Widows/wards of Defence Personnel who died while in service with death attributable to military service.

Priority IV - Wards of disabled in service and boarded out from service with disability attributable to military service.

Priority V - Wards of Ex-Servicemen and serving personnel/para military/ police personnel who are in receipt of the following Gallantry Awards:

1. Param Vir Chakra 2. Ashok Chakra 3. Mahavir Chakra 4. Kirti Chakra 5. Vir Chakra 6. Shaurya Chakra 7. Sena/Nau Sena/ Vayu Sena Medal 8. Mention-in-Despatches 9. President's Police Medal for Gallantry 10. Police Medal for Gallantry

Priority VI – Wards of Ex-servicemen.

Priority VII – Wives of:

- 1. Defence personnel disabled in action and boarded out from service
- 2. Defence personnel disabled in service and boarded out with disability attributable to military service
- 3. Ex-servicemen and serving personnel who are in receipt of Gallantry awards.

Priority VIII – Wards of serving personnel.

Priority IX - Wives of serving personnel.

- f) **Person with Disability:** 5% of the total seats (Horizontally) in each category are reserved for candidates belonging to 'Person with Disability' subcategory in accordance with the provisions of 'The Rights of Persons with Disabilities Act 2016' (PwD Act)
- g) **Kashmiri Migrants (Supernumerary):** 01 (One) seat, over and above the total intake in each campus of DTU is available under this category.

Note:

- I. In case of category (a) and (b), the vacant seats are interchangeable.
- ii. In case, sufficient numbers of eligible candidates from category (c) are not available, the vacancies will be treated as unreserved.
- iii. Seats under sub-category (f) are interchangeable within the sub category if sufficient number of candidates is not available in a particular group.

iv. In case, sufficient number of eligible candidates from the sub categories mentioned at (e) and (f) are not available, the vacancies will be treated as unreserved in the respective category.

- v. Under CW sub-category, the seats will be filled based on the priority, i.e. all eligible candidates of priority-I will be allotted seats based on their ranks until the ranks exhaust or seats exhaust under CW sub category. Remaining vacant seats, if any, will be allotted to the priority-II in the similar way, and so
- vi. The reservation under CW sub category is available only to such candidates who fall under the listed priorities.
- vii. It is the sole responsibility of the candidate to prove his/her eligibility for claiming reservation under any of the reserved categories/sub categories. The candidates claiming reservation under SC/ST/OBC/EWS/KM categories, CW/PwD sub-categories will be required to upload scanned copy of the respective certificates and produce the

original certificate of the respective reserved category/sub-category issued by the competent authority (as mentioned in this information brochure) in the respective institutes at the time of physical verification of the documents. If the reserved category/ sub-category certificate is not found in order, no benefit of the reserved category/ sub-category will be given and the candidate shall be considered for allotment in GENERAL category in subsequent rounds on submission of written request by the candidate to CMAC in person or email in this regard, as per the eligibility of the candidate and availability of seats. If such candidate is able to produce his/her category certificate before the commencement of further round, he/she shall be considered for the category in that round and will be allotted a fresh seat as per the vacancy available and his/her merit.

viii. After exhausting the complete list of registered SC, ST, OBC and EWS candidates, the vacant seats will be treated as unreserved in the "SPOT ROUND"

Selection Procedure

- 1. All the applications received will be shortlisted on the basis of performance in CAT- 2021/MAT-2021/MAT-2022/ Graduation percentage with one year of experience.
- 2. The shortlisted candidates are required to appear for a Personal interview and / or Group discussion.
- 3. Admission shall be made on the basis of the final merit list prepared on the basis of CAT-2021 / MAT-2021/ MAT-2022/ Graduation percentage with one year experience and performance in Personal Interview and / or Group discussion.
- 4. The final merit will be generated by giving 80% weightage to CAT/MAT percentile/ Graduation percentage with one year experience and 20% weightage to Personal Interview and / or Group discussion.
- 5. The preference will be given to the candidates in the following order-
- I. Candidate with valid CAT percentile
- ii. Candidate with valid MAT percentile
- iii. Candidates graduated with at least 60% with one-year work experience.
- 6. CAT percentile (rounded up to two decimal places) of 2021 will be considered whereas the best percentile of MAT-2021/ MAT-2022 will be considered.

- 7. Allotment of University will be done on the basis of rank of the candidate in the merit list and 'preference of the University' applied by the candidate.
- 8.CMAC may decide an appropriate cut-off percentile of CAT/MAT/Graduation percentage with one year experience to prepare respective merit lists of the students for the purpose of shortlisting the candidates for admission.
- 9. In case of tie in the final merit list, the following criteria shall be used:
- a) The candidate with higher CAT percentile shall be ranked higher.
- b) In case of tie in CAT percentile, the candidate with higher MAT percentile shall be ranked higher (in case of candidates with both CAT and MAT percentile).

- c) In case of tie in CAT/MAT percentile, candidate with higher work experience will be ranked higher.
- d) In case of tie in work experience, candidate with higher aggregate marks in graduation will be ranked higher.
- e) In case of tie in graduation marks, the candidate shall be ranked according to the date of birth i.e. the person older in age will be ranked higher.

Note: The University may invite fresh applications against vacant seats, if any, by following an alternative admission criterion as decided by the CMAC.

Admission Counselling Procedure

1 Registration Process

All candidates desirous of seeking admission to the MBA programme at DTU are required to visit website www.dtu.ac.in and fill registration form, pay a non-refundable registration fee and fill the choices for allotment of seat. The details of registration fee are given below:

- I)The candidate will initially authenticate himself/herself by entering personal details and will choose the password for subsequent logins. After successful registration, an application number will be generated by the system and provided to the candidate.
- II) Candidate will login by using system generated application number and password to complete the remaining activities to complete CMAC application form in steps.
- III) Candidate will use the Application Number and chosen password during registration for subsequent

logins. After successful login, candidate will be redirected to the home page to complete the remaining activities like Application form submission, upload images and documents, choice filling, registration fee payment etc.

IV) Candidate must ensure that the BANK ACCOUNT details filled by him/her at registration must be valid and should BELONG TO THE CANDIDATE OR HIS/HER IMMEDIATE FAMILY MEMBERS. This bank account will be used to refund academic fee/spot round fee if required by CMAC Delhi.

V) On completion of application form, candidate needs to upload all relevant documents as per his/her category/sub-category. This will include his/her scanned copy of photograph, class X mark sheet, XII mark sheet, Graduation certificate/mark sheet, Category certificate (if any for EWS/OBC/SC/ST/PWD/CW/KM), sub-category certificates, CAT-2021/MAT-2021/ MAT-2022 percentile and work experience details if any. Before final submission, candidate will review the filled data and can edit again before final submission.

VI) Once application form is complete in all respect and all the required documents have been uploaded, candidate need to confirm his/her registration form. The candidate is not permitted to edit/change details filled in the registration form once the candidate confirms the final submission. If candidate leaves the form incomplete, he/she can continue filling application form through CMAC login link.

VII) Once application form is complete and confirmed by the candidate, he/she will have to pay a non-refundable registration fee. Candidates are required to make a payment through configured payment gateway.

VIII) Candidate has to take the printout of the registration form signed by Guardian / Parents and Self, which has to be submitted at the time of admission/reporting in the institute.

Note:

- I) After successful registration and fee payment, candidates are required to visit the website www.dtu.ac.in again and fill choices for universities.

- 2. The choices filled by the candidates during ONLINE registration will be processed centrally.
- 3. As per the eligibility of the candidate, available seat information relating to University will be displayed.
- 4. Admission shall be made on the basis of combined merit list prepared on the basis of CAT-2021/ MAT-2021/ MAT-2022 percentile and performance in Personal Interview and/or group discussion.
- 5. Allotment of seat will be done on the basis of rank of the candidate in the merit list and 'preference of the University' applied by the candidate after verifications of documents in physical mode of counseling.

2.1 Payment of seat acceptance fee

All the candidates who get an allotment will have to pay part admission fee (Rs.1,00,000 – Rupees One Lakh through demand draft) as per the admission schedule, failing which his/her allotted seat will stand automatically cancelled and the candidate will not be considered for subsequent rounds of seat allotment. However, such candidates are eligible for spot round of counselling. Balance fees need to be paid by the candidate in the respective University at the time of academic registration.

2.2 Upgradation

Certificates required for claiming Reserved Seats

Candidates applying for any reserved seat (i.e. EWS, SC, ST, OBC-NCL, CW, PD,KM) must upload the scanned copy of the certificates (as applicable) as mentioned below at the time filling up of the ONLINE application form.

I. Scheduled Caste (SC)/Scheduled Tribe (ST)/Other Backward Class (OBC-NCL):

For admission to a seat reserved for Scheduled Caste/ Scheduled Tribe/ Other Backward Class (NCL), candidate must produce a certificate, in original, issued from an approved district authority stating the Scheduled Caste/ Scheduled Tribe/Other Backward Class (NCL), to which the candidate belongs. A list of approved authorities is given below:

- a. District Magistrate / Additional Magistrate / Deputy Commissioner/ Collector / Additional Deputy Commissioner/Deputy Collector/ 1st Class Stipendiary Magistrate / City Magistrate (not below the rank of 1st Class Stipendiary Magistrate), Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- b. Revenue Officer not below the rank of Tehsildar.
- c. Sub-Divisional Officer of the area where the candidates and/or his/her family normally resides
- d. Administrator / Secretary to Administration / Development Officer (Laccadive & Minicoy Islands).

NOTE:

- 1. The candidate seeking admission under reserved categories has to mandatorily upload the caste/ category certificate in his/her name at the time of filling up of the ONLINE form. The certificate in the name of either of the parents (mother/father) or any other family member is not acceptable and the candidate will not be entitled even for provisional admission.
- 2. OBC (NCL) candidates are required to produce a caste certificate issued after March 31, 2022 from the authorities as mentioned above. - b. The candidate with benchmark disabilities shall produce the medical certificate issued by the Govt. Hospitals duly notified by the Govt. of NCT of Delhi/other State government and further duly verified by the Chief Medical Officer of the concerned Government Hospital.
- c. A certificate duly recommended by Vocational Rehabilitation Centre for the handicapped, 9-11 Vikas Marg, Karkardooma, Delhi 110092.

III. Kashmiri Migrants:

The candidates seeking admission under Kashmiri Migrants seats must upload the following documents at the time of filling up of the online application:

- a. Certificate of registration as Kashmiri Migrants issued by the Relief Commissioner, Jammu or Divisional Commissioner, Delhi to establish the status of the applicant as registered migrants.
- b. Degree and Mark-sheet of the qualifying examination.
- c. Secondary School Examination or an examination recognized as equivalent thereto (showing the Date of Birth).
- d. Proof of property in Kashmir of the parent of the candidate.
- e. Proof of current residence such as Ration Card, Photo Identity Card issued by the Election Commissioner, Driving License, etc.

IV. Economically Weaker Section

a. Criteria for Income and Assets The benefit of reservation under EWS can be availed by persons who are not covered under the scheme of reservation for SCs, STs and OBCs upon production of an Income and Asset Certificate issued by a Competent Authority based upon the following criteria:

Candidates whose family has gross annual income below Rs 8.0 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc.

for the financial year prior to the year of application. "31st March, 2022".

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:i.5 acres of agricultural land and above; ii. Residential flat of 1000 sq. ft. and above; iii. Residential plot of 100 sq. yards and above in notified municipalities; iv. Residential, plot of 200 sq. yards and above in areas other than the notified municipalities. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding

test to determine EWS status. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority after March 31, 2022. - I. A certificate from the respective C.O. Unit in respect of serving personnel.
