No person who himself is registered for Ph.D. degree at this University or any other Institution, would qualify to act as supervisor. The mandatory eligibility conditions for supervisor:

- (a) A valid Ph.D. degree from a recognized University/Institution.
- (b) Actively engaged in research and has published at least five research papers in referred national/international journal of the concerned subject area".

This may be treated as 'MOST URGENT'.



It is informed that in exercise of the powers conferred under Section 32 Sub-section (2) of the DTU Act, 2009, the Board of Management in its 39th meeting held on 13.11.2020 vide agenda number 39.6 considered and approved the amendments/ additions in the Regulations of Ph.D. Ordinance, 2017 as below:

The eligibility criteria for supervision of Ph.D. Scholars mentioned in R.7.2 of Ph.D. Ordinances & Regulations of DTU is reproduced as under:

R.7.2 A Supervisor shall be any full-time academic staff of the University (including the academic staff of erstwhile Delhi College of Engineering) including Scientific/Design staff of the University with a Ph.D. degree. No person who himself is registered for Ph.D. degree at this University or any other Institution, would qualify to act as supervisor. The mandatory eligibility conditions for supervisor:


(a) A valid Ph.D. degree from a recognized University/Institution.

(b) Actively engaged in research and has published at least five research papers in refereed national/international journal of the concerned subject area.

(c) Less than eight (for Professor), or six (for Associate Professor) or four (for Assistant Professor) registered research students/candidates in the University. A candidate registered under joint supervisor will be counted as half for this purpose.

(d) All eligible faculty members of DTU shall get one additional supernumerary Ph.D. seat for foreign student. However, if they want to take/guide more than one student(s), it will be considered under the existing prescribed quota.

All the DRC chairperson & HoDs are advised to ensure the above eligibility conditions are being followed strictly.



NOTIFICATION

In exercise of the powers conferred under sub-section (1) of Section 23 of the Delhi Technological University Act, 2009 (Delhi Act 6 of 2009), the Board of Management of Delhi Technological University in its 37th meeting held on 29.05.2020 vide agenda number 37.6 approved the revision of Guidelines for Progress Linked Award of DTU Teaching and Research Fellowship to the Ph.D. Students notified vide notification No: **F.DTU/Order/BOM/25/2014/Vol-III/206**. In supersession of earlier notification No. **F.DTU/IRD/2020/12/2537** dated 21/07/2020, the revised guidelines are as under:

1. Full time Ph.D. students with fellowship admitted w.e.f. the session 2019-20 will be paid a consolidated amount of Rs. 32500/- (inclusive HRA and any other allowance) per month (or as and when amended by university from time to time) and a contingency of Rs. 17500/- (or as and when amended by university from time to time) annually. They will also be assigned a teaching load of 08 hours (lab/lectures) per week by the department.
2. They shall become eligible to be considered for an enhanced amount of Rs. 36000/- per month (or as and when amended by university from time to time) after getting acceptance/ publishing one SCI/SCI expanded/SSCI index Journal paper in Category A/B OR two SCI/SCI expanded/SSCI index Journal papers in Category C and satisfying all conditions mentioned in Annexure I (refer to Annexure I for details). The paper published must have been communicated after his/ her date of Ph.D. admission at Delhi Technological University and the sole authors of the paper must be the candidate/ or candidate and supervisor(s) both, as per requirement of Ph.D. Ordinance 2017, Clause R15.2(iii).
3. A committee consisting of Chairperson DRC, HoD, Supervisor(s) and a nominee of the Vice Chancellor will consider the request of the candidate for enhancement of fellowship and will give specific recommendations to the Dean-PG who will send the case for approval of the Vice Chancellor.

In case Supervisor of the candidate happens to be the DRC Chairperson and/ or HoD, then Vice Chancellor will nominate another senior Professor from the department to this committee.

4. In case a Ph.D. scholar admitted in academic year 2019-20 onwards gets additional Journal paper accepted or published in Category A/B and satisfies all conditions mentioned in Annexure I, then he/she may be considered to be eligible for enhanced fellowship amount of Rs. 40000/- per month (or as and when amended by university from time to time) by the same procedure as mentioned above. However, again the sole authors of the paper must be the candidate/ or candidate and supervisor(s) both, as per requirement of Ph.D. Ordinance 2017, Clause R15.2(iii).

5. In general, a candidate will be awarded fellowship only up to 04 years from his date of admission; however, it can be extended to the fifth year in case he/she has published at least two papers as per the specifications given in Ph.D. Ordinance 2017, Clause R15.2(iii).
6. Full time Ph.D. Scholars admitted in academic year 2017-18 and 2018-19 will be considered eligible for enhancement from JRF to SRF or for fifth year of fellowship (as per Agenda No. 24.24 of Minutes of 24th BOM Meeting held on 09/06/2017) only if they have publications as per specifications given in Ph.D. Ordinance 2017. However, they may be eligible to avail the benefit of enhanced fellowship at the rate of Rs. 40000 (or as and when amended by university from time to time) only after they publish SSCI/SCI/SCI expanded index journal papers as per conditions given in point no. 4 after 29.05.2020.
7. To encourage the existing full time registered Ph.D. students without fellowship, it is decided that they may also be eligible to be considered for the award of Ph.D. fellowship at the rate of Rs. 36000/40000 per month (or as and when amended by university from time to time) plus contingency in case they publish SSCI/SCI/SCI expanded index journal papers as per conditions given in point no. 2 and 4 of this document and as per specification given in Ph.D. Ordinance 2017, subject to availability of fellowships *at* in that academic year.

All eligible cases will be considered once in the odd semester, and once in the even semester. If approved, they will be awarded fellowship w.e.f. the subsequent 1st August or 1st January as applicable. However, no arrear will be given in any such cases and the fellowship will be awarded maximum up to four/five years, as the case may be, from their date of admission to the Ph.D. program. They will also be assigned a teaching load of 8 hrs. per week.

8. In case X number of fellowships are announced by the University at the beginning of an academic year, then a suggested distribution can be as under:

Direct Admissions : 70% of X Fellowships

Existing Admitted Scholar(s) : 30% of X Fellowships

However, the number of fellowships to be announced for a specific academic year and their distribution will be decided by a Committee with the Vice-Chancellor as Chairperson, Pro Vice-Chancellor, Dean (PG), Dean (IRD) as members and Registrar as its Member Secretary.

9. In case a Ph.D. scholar getting fellowship submits his/her thesis before the expiry of the duration of fellowship; then he/she will continue to get the fellowship till the expiry of the duration or till the end of that semester, that is, up to 30th November for odd semester and 30th June for even semester, whichever is earlier.

10. The students already admitted in the Ph.D. program without fellowship will not be allowed to apply afresh against any subsequent admission announcement. A student will be considered to be eligible only if he/she is not on the roll of Ph.D. program of the University on or before the date of his/ her submitting application against the fresh admission program announced.
11. Power to remove difficulties: If any difficulty arises in giving effect to the provisions of these guidelines, the Vice Chancellor may, make such provisions, not inconsistent with the provisions in these guidelines, as appear to be necessary or expedient for removing the difficulty.

The guidelines shall be applicable with effect from the date of approval of the Board of Management (29.05.2020).

Annexure I

Guidelines for enhancement of DTU Teaching & Research Fellowship to Ph.D Students

The publication made in the journals, which seek Article Processing Charges (APC), shall not be considered for fellowship grant or enhancement irrespective of the listing in the publication houses specified in the below categories.

Category A

Selection Criteria: The paper must be a Science Citation Index (SCI)/Social Science Citation Index (SSCI)/SCI expanded journal paper of impact factor at least two, and published in the following:

- Nature Journal
- Science
- Harvard Business Review

Category B

Selection Criteria: The paper must be a journal paper with impact factor atleast 3.0 for Institute of Electrical and Electronics Engineers (IEEE) Transactions and one for all other journals, indexed in SCI/SSCI or SCI expanded and published in the following:

1. Proceedings of Royal Society
2. American Mathematical Society
3. American Physical Society
4. American Society for Civil Engineers (ASCE)
5. American Society for Mechanical Engineers (ASME)
6. IEEE Transactions (TRIF \geq 3)
7. Association for Computing Machinery (ACM) Transactions
8. Institute of Civil Engineering Publishing, London
9. Institute of Mechanical Engineering, London
10. American Society of Testing Materials (ASTM)
11. Nature Publishing Group

In addition to the above list, the journals with impact factor equal to or more than thirty (30) will also be considered in category B.

Category C

Selection Criteria: The paper must be a journal paper with impact factor atleast one, indexed in SCI/SSCI or SCI expanded and published in the following:

1. IEEE Transactions (TRIF $<$ 3)
2. IEEE Journals
3. Springer
4. Elsevier (Science Direct)

The publication houses in the above categories will be added or deleted as per Guidelines for Award of Published Papers for Researchers of Delhi Technological University (F.DTU/Council/BOM-AC/Notification/31/2018/2443) as amended from time to time by the university.
