Executive MBA in Data Science & Analytics (Batch 2024-26)

It is hereby informed that Special Spot Admission for the Executive MBA in Data Science and Analytics programme offered by the University School of Management & Entrepreneurship, East Delhi Campus, Delhi Technological University will be held on **24th August 2024 (Saturday)**.

<p>Reporting Date and Time 24-08-2024 (Saturday), 10:00 AM Venue Auditorium, East Delhi Campus, DTU</p>

(i) Eligibility Criteria:

- Mathematics in standard 12th or Graduation (at least one paper) with 60% marks.
- Graduation with minimum 50% marks or equivalent CGPA from any recognized university/institution. There will be 5% relaxation in the eligibility for reserved categories as per DTU norms.
- Managerial/Professional/Technical work experience in industry/organisation of at least three years by 24.08.2024 and NOC from the current employer.

(ii) Instructions to the Candidates:

The candidates appearing of the special spot round admission are required to follow these instructions:

- Candidates appearing for Special Spot Round are required to fill the Google form by clicking on the link given below by **23 August 2024, 11:00 PM**

- The candidates are required to report for the special spot round strictly at 10:00 AM at East Delhi Campus, DTU, Vivek Vihar Phase II, Delhi-95 on 24th August, 2024 (Saturday). Final attendance will be called at 11:00AM.**
- The candidates fulfilling the eligibility criteria are required to report along with the required original documents as mentioned below:
 - Proof of Date of Birth

- (ii) Graduation Marksheets
- (iii) Proof of atleast one paper of Mathematics in Graduation/Class XII
- (iv) SC/ST/OBC/EWS category certificate if applicable, in the format prescribed in the admission brochure
- (v) Experience certificate and NOC from the current employer
- (vi) Original Medical Certificate
- (vii) One set of self-attested photocopies of documents mentioned above and two passport size photographs.

4. Admission is subject to the verification of the original documents. The original documents will be returned to the applicants after verification.

5. Instructions regarding registration and admission fees:

- (i) All candidates appearing for the special spot round are required to submit DD of Rs. 1500/- (Fifteen Hundred only) **as registration fee (Non-refundable)**. The Demand Draft should be in favor of “**Registrar DTU Admission East Delhi Campus**”, **Payable at Delhi**.
- (ii) The candidates who will provisionally be admitted, are also required to submit a DD of **Rs. 2,80,700/- (Two lakh eighty thousand seven hundred only)** in favor of “Registrar DTU Admission East Delhi Campus”, Payable at Delhi, as annual admission fees for the academic session 2024-25. **This demand draft may be arranged in advance for submission on 24.08.2024 (Saturday).**

6. Withdrawal of seat is not allowed for SPECIAL SPOT round and admission fee will not be refunded

7. If an applicant is found ineligible at any stage before or after admission or during any stage of the programme, his/her candidature/admission will be cancelled without any notice and suitable action shall be initiated against him/her.
