The candidates are required to report for counseling cum admission process on **07/08/2024** (Wednesday).

Bawana Road, Delhi-110042.

Note: The students are provisionally selected and are subject to physical verification of documents. The candidates are required to bring the following documents in original.

1. Class X Certificate as a proof of Date of Birth.
2. Degree and all Mark Sheets of qualifying examinations.
3. Category Certificate (SC/ST/OBC/EWS).
4. **Original documents in respect of experience mentioned in application form.**
5. No Objection Certificate from the employer with current designation of the candidate and permission to attend the classes for the whole day on Saturday and Sunday during all the four semesters in the period 2024-26.
6. Proof of full payment of fees of first year.

Note: Admission of the candidate shall be confirmed only after providing all documentary proof of educational qualification, experience and subsequent verification of both.


Fee: The admission fees for the session 2024-26 is **Rs. 2, 80, 700/- (Two Lakh Eighty Thousand Seven Hundred only)** for First year. The selected candidates are required to pay the full fees of first year.

The admission fees can be paid online through Credit card/ Debit card /NET banking. The convenience charge (online transaction) may be extra as per banking gateway on every online admission fee payment. The candidates are required to login on the admission portal where they had registered and click on admission fee payment link and pay the fees.
