(i) Exemption from Screening Test, (ii) Award of weightage marks, in Screening Test.**

Reference be made to earlier clarifications for the post of Assistant Professor vide letter no.F.DTU/Rectt./AP/2024/F-950/3096 dated 13-08-2024, in which it was stated that candidates seeking exemption from screening test/ award of weightage in screening test will be required to submit an undertaking with all relevant details. The Annexure for that undertaking has been slightly modified and attached as Annexure-1.

Through this notice, all the candidates who have sought exemption from screening test/ award of weightage marks, are required to fill up the undertaking given in Annexure-1 of this notice and submit the same by email as a PDF document to [recruitment@dtu.ac.in](mailto:recruitment@dtu.ac.in).

Meanwhile the lists of candidates (i) provisionally exempted from screening test, and (ii) provisionally awarded of weightage marks in the screening test, are being tentatively prepared subject to fulfilment of condition stated in the advertisement (necessary documents in support of the claim should be submitted along with the printout of the online application form) as per 'vii to xi' in the subhead 'procedure of selection' described in advertisement no. 02/2024. These lists do not guarantee exemption/ award of weightage, as the same will be assessed based on the undertaking provided by the candidates.

Candidates not seeking (i) exemption from screening test, (ii) award of weightage in screening test, are not required to submit this undertaking.

Further, candidates who have not applied earlier for (i) exemption from screening test (ii) award of weightage in screening test in the application form, must not apply at this stage and do not give this undertaking.

This undertaking is required to be submitted by email ([recruitment@dtu.ac.in](mailto:recruitment@dtu.ac.in)) within one week positively from the date of displaying of lists of candidates (i) provisionally exempted from screening test, and (ii) provisionally eligible with weightage in screening test, on DTU website.
