<u>The candidates need to come for admission along with the following documents in original</u> and ONE set of self-attested photo-copies of the original documents, two recent passport size photographs, printout of the registration form duly signed by the candidate and Demand Draft of Rs. 1,00,000/- in favour of ''Registrar, Delhi Technological University'' payable at New Delhi, for the purpose of verification at the time of admission.

Below mentioned certificates/ documents in original must be required to be presented by the candidates (Section 8 of M.Tech. by Research Admission Brochure, January 2025):

- a. Date of Birth proof
- b. All mark sheets and certificate of qualifying examination (Graduation).
- c. If result for final semester is not declared, then candidate will be required to submit an Undertaking as per format placed at Annexure-3 of admission brochure.
- d. SC/ST/OBC/Persons with disability Certificate(s) whichever applicable, on the basis of which reservation is claimed.
- e. OBC (NCL) candidates are required to produce a caste certificate issued after March 31, 2024 from the authorities as mentioned in Annexure-4 of admission brochure. However, if the certificate is issued prior to March 31, 2024, it must be accompanied with an additional certificate regarding the present non-creamy layer status of the candidate, issued by the same competent authority. This additional certificate must have reference of his/ her already issued original caste certificate.
- f. Candidates applying for admission to seat reserved for Differently Abled Person (PwD) subcategory, the candidate must produce the certificates in original at the time of document verification as per Annexure-5 of admission brochure.
- g. EWS Income and Asset certificate issued by the Competent Authority (For those who have applied for M. Tech. by Research admission under EWS category) as per Annexure-6 of admission brochure issued after 31st March, 2024.
- h. The candidates seeking admission under Kashmiri Migrants (KM) seats must produce the following documents, in original, at the time of document verification:
 - 1. Certificate of registration as Kashmiri Migrants issued by the Relief Commissioner, Jammu or Divisional Commissioner, Delhi to establish the status of the applicant as registered migrants as per Annexure-7 of admission brochure.
- i. Research proposal.
- j. In case of non-availability of latest category certificate i.e. EWS and OBC, candidate can submit an undertaking given in Annexure-8 and Annexure-9 of admission brochure respectively at the time of application filing or during admission.
- k. Demand Draft drawn in favour of "**Registrar, Delhi Technological University**" payable at New Delhi as annual fee (Rs. 1,00,000/-).

INSTRUCTIONS TO THE CANDIDATES:

- If a candidate is found ineligible at any stage before or after examination / interaction/ interview/ declaration of result or during any stage of the programme, his / her candidature / admission will be cancelled without any notice and suitable action will be initiated against him / her including forfeit of the fee.
- 2. The candidate seeking admission under reserved categories has to produce the caste/category certificate in his/her name at the time of counseling **is mandatory**. The certificate in the name of either of the parents (mother/father) or any other family member is not acceptable and the candidate will not be entertained even for provisional admission. The caste certificate must be uploaded in online admission portal as well.
- 3. It is the sole responsibility of the candidate to prove his / her eligibility for claiming reservation under any of the reserved categories. A candidate who is offered a seat under reserved category / sub-category during seat allotment round and fails to produce appropriate document in support, his/her allotted seat will be cancelled.
- 4. Offline Counselling requires a candidate to visit the venue in person and appear for interaction/ interview. If selected, based on the recommendation of selection committee, the candidates need to appear for document verification and submit the fee to lock the seat.
- 5. Candidates must note that the admission fee must be paid in single installment failing which the admission offer will be withdrawn.
- Upon payment of Admission fees, the candidate will be granted provisional admission. Admission is subject to the verification of the original documents. The original documents will be returned to the students after verification.
- 7. For withdrawal/refund policy, please check DTU website.
- 8. Candidates are advised to visit University website regularly for notification in this regard.

All provisional eligible candidates are called for counseling.
