After detailed discussion, the following has been decided :-

1. Sh. Kamal Pathak, Member Secretary of Committee constituted for assessment and evaluation of intermediate semester students presented the recommendations of the Committee. There were some suggestions given during the meeting. The Chairman of the Committee has been requested to make the required modifications and put up as agenda for the ensuing Academic Council meeting to be held on 29.7.2020.

2. Dean (IRD) has been requested to submit the criteria for evaluation of M.Tech major project and the same is to be reported to Academic Council.
3. The matter related to admission of part time/ sponsored candidates in M.Tech programme was discussed. Dean (PG) has been requested to clarify about the eligibility of candidates working in private/ autonomous institutions and if required, the extension of date for admission of these candidates may be advertised.
4. Dean(UG/PG) has been requested to issue notice for submission of the annual fee of UG/PG students respectively.
5. Prof. Rajeshwari Pandey, Associate Dean (UG) presented tentatively academic calendar for the academic year 2020-21. It has been decided that there will be no mid & end semester examination. The evaluation for the next semester will be only on the basis of continuous evaluation. Accordingly, the calendar may be modified and to be presented to Academic Council.
6. Prof. Neeta Pandey, Coordinator (TEQIP) requested Director (IQAC) for providing SAR for PG Programmes and also requested all the Heads of the Departments to use atleast one virtual laboratory class in the next semester.
7. As decided, Dean (UG/PG/IRD) has been requested to submit notifications of previous Academic Council decisions to the Registrar's office for issuing of notifications.
8. Sh. Kamal Pathak, COE requested all the HoDs to request their faculty to submit CW/MTE/PRS Components by July,20,2020.
