

In exercise of the powers conferred under Sub-section (1) of section 23 of the Delhi Technological University Act, 2009 (Delhi Act 6 of 2009) and Statutes 10(h) of Delhi Technological University, the Board of Management in its 54th meeting held on 18.02.2025 vide agenda item no. 54.5 has approved the revised Recruitment Rules for the Post of **Knowledge Network Assistant**. 6.	Age limit for direct recruitment	30 years NOTE: Relaxable upto 5 years' in accordance with the instructions and orders issued by the Govt. of India/GNCTD from time to time.

Educational & other qualification required for direct recruitment	Essential Qualification: B.E./B.Tech. in Computer Science & Engineering /Information Technology /Electronics & Communication Engineering. Desirable Qualification: Certification course in networking such as CCNA etc. or similar course in networking.
