- 1) If any security personnel are required to be deployed for the security of the vending machines, the cost will be beared by the Vendor.
- 2) The license fee is being exempted for providing the space in DTU as the activity is purely of student welfare (considering their security in the late hours of hostel) not of commercial type.
- 3) A single contact number or email id will also be displayed on or nearby the vending machine, so that any suggestion/complaint of the students may directly be sent to the vendor by students themselves.
- 4) The maintenance of the Vending Machines shall be borne by the Vendor.
- 5) In case of any damage or loss to the Vending Machine, the DTU will not be responsible in any manner.
- 6) Any dispute arising out of or in connection with this MOU shall be resolved through mutual discussion only between VC of the university and Managing Director of the company, in case of no conclusion is driven, the jurisdiction will come under Delhi Courts.
- 7) Electricity Charges shall be as per actual consumption (sub meter to be installed by vendor at their own cost).
- 8) The eatable materials which will be provided by the vendor through vending machines must be of superior quality, approved by the FSSAI. In case of inferior quality of the eatable materials reported by the users/ any damage in this regard will be compensated by the vendor as decided by the Competent Authority.
- 9) The product on sale by the vendor through Vending machines shall not exceed the MRP.
