- **Venue:** Room no. FF-106 in Delhi School of Management, Delhi Technological University Bawana Road, Delhi-110042.

Note: The students are provisionally selected and are subject to physical verification of documents. The candidates are required to bring the following documents in original.

- Class Xth Marksheet and Certificate.
- Class XIIth Marksheet and Certificate.
- Graduation Marksheets and Degree.
- Caste Certificate (SC/ST/OBC/EWS/Defence/Kashmiri Migrant), if applicable. The OBC(NCL) and EWS candidates are required to produce category certificate issued after March 31,2026.
- Work Experience (after graduation) Certificates
- **Proof of full payment of fees of first year.**

Fee: The MBA(Executive) admission fees for the session 2026-28 is Rs. 3,07,000/- (Three Lakh Seven Thousand only) for First year. The selected candidates are required to pay the full fees of first year. The admission fees can be paid online through Credit card/ Debit card /NET banking. The convenience charge (online transaction) may be extra as per banking gateway on every online admission fee payment. The candidates are required to login on the admission portal where they had registered and click on admission fee payment link and pay the fees. The fee is to be paid online. **The candidates are required to deposit the fee from 12/08/2026 (Wednesday) to 16/08/2026 (Sunday) 5:00 pm.**
